4. Litter issues

Notification had been sent to BCBC regarding the ongoing litter issues informing them that until such time that positive action by BCBC is taken to resolve the matters of concern the Town Council would no longer be supporting litter activities in the Pencoed area.

5. Skatepark Organisation
