The Mayor Cllr D. John BEM delivered the following address;

How can I best describe my Mayoral Year?

It has certainly been a period of change, particularly as far as the Town Council is concerned.

Resignations, bye-elections, co-options all adding up to changing the Council's make-up.

It was also a period when, on two occasions, I was introduced to the Local Ombudsman through the generosity of a Mr. Morris and Mrs. Hillman who accused me of misusing my position as a member of Pencoed Town Council; its Mayor and as Clerk to the Conservators of the Coity Wallia Common.

I am glad to say that the Ombudsman, in his wisdom, coupled with circumstances surrounding the accusations, decided not to investigate the complaints.

Unfortunately, in January 2019 1 contracted a notifiable virus called Hepititis E necessitating a stay in hospital and a long period of recovery at home and I would like to take this opportunity of thanking the Clerk and the members of the Council for their help and visits during my indisposition.

Coming to my Mayoral Year's activities.

The usual civic services, golden weddings, 90th birthdays and concerts made up the normal year, the highlight however was the official opening of the Pencoed Primary School.

The new school is a fine example of thoughtful architecture and incorporates all the modern facilities to make the pupils' learning processes so much attractive and productive.

Sadly, the old school buildings were to disappear to make way for a housing development. The buildings themselves had dominated Pencoed's landscape for so many years and had played such an important part in developing many childrens' lives on their journey into adulthood and my earliest recollection of the complex was as a pupil in the infants section in 1935.

One of my last duties was the cutting of a tape at the new Starbucks Coffee Centre. Members of the Town Council and the local MP were also present and before the tape cutting ceremony we were treated to a coffee testing experience which was quite unusual.

My thanks to the Deputy Mayor for he help during the year, albeit a short one, and to the Clerk and Leader.
