

# Auditor General's report and audit opinion

I certify that I have completed the audit of the Annual Return for the year ended 31 March 2025 of Pencoed Town Council. My audit has been conducted on behalf of the Auditor General for Wales and in accordance with the requirements of the Public Audit (Wales) Act 2004 (the 2004 Act) and guidance issued by the Auditor General for Wales.

## Audit opinion: Qualified

Except for the matters reported below in my Basis for Qualification, on the basis of my audit, in my opinion no matters have come to my attention to give cause for concern that, in any material respect, the information reported in this Annual Return:

- has not been prepared in accordance with proper practices;
- that relevant legislative and regulatory requirements have not been met;
- is not consistent with the Council's governance arrangements; and
- that the Council does not have proper arrangements in place to secure economy, efficiency and effectiveness in its use of resources.

#### **Basis of Qualification**

## **Accounting Statement**

I am unable to conclude whether or not the Accounting Statement properly presents the Council's receipts and payments and financial position:

- The Council has not provided a full and quantified explanation of variances between the current and prior years' accounts for Line 3 & Line 12 of the Annual Return. Therefore I am unable to conclude whether or not the Accounting Statement is a full record of the Council's receipts and payments.
- The accounting statement has not been prepared in accordance with proper practice. The prior year accounts are prepared on a receipts and payments basis. Therefore, the balances carried forward (lines 7 and 11) should be equal.
- The Council has re-stated figures on its annual return (staff costs and debtors).
   However, the Council has not adequately disclosed that it has re-stated these figures. The Council must make a disclosure when re-stating its figures and make it clear which figures have been re-stated on the annual return.

#### Other matters and recommendations

I draw the Council's attention to the following matters and recommendations which do not affect my audit opinion but should be addressed by the Council.
